Street Vending Coordinator's Report

Enforcement -

There has been no enforcement activity since the last VOC meeting.

First Half-Price Mall/Concourse License -

One new Mall/Concourse Food Vendor (The Plckle Jar) has paid half-price to use an unoccupied site on the 700 block of State Street, paying half price for the remainder of the season.

More Construction -

Comprehensive 2016 construction on the northern half of the outer Capitol Square will make sidewalks unusable for potentially long periods of time. The current plan is to abandon many actual Mall/Concourse Food Vendor and Arts and Crafts Vendor sites while construction is ongoing until approximately Labor Day. Some vendors may be "permanently" relocated to Wisconsin Ave., or to East. and West Washington. The sites in front of Anchor Bank on W. Main Street will also be unavailable for at least a year.
