Neighbors from throughout South Madison worked with Traffic Engineering staff to come up with Alternative 2 after many South Siders expressed the need for more parking instead of buffered bike lanes on new Cedar Street.

Alternative 2 is designed to be provisional. Should the added parking prove unnecessary, the lanes can be repainted at a later date to eliminate the 5 parking spots and include buffered—instead of regular—bike lanes.

In 2020, South Siders spoke out at Transportation Commission meetings to protest local lobbyists' push for buffered bikes lanes on new Cedar. Their <u>reasons for supporting regular bike lanes AND more parking</u> are:

- 1) Luna's will be located between two major thoroughfares, Fish Hatchery and South Park, neither of which is especially safe for cycling.
- 2) Cycling and public transit are unfeasible modes of transport for the many community members who may shop with children in tow, who are seniors or disabled, or who must shop during their limited spare time.
- 3) The five additional on-street parking stalls afforded by Alternative 2 are an important part of maximizing the on-site parking needed to make the new supermarket a success. Nation-wide studies show that successful 24,000-square-foot supermarkets most often rely on 80 to 100 on-site parking stalls; yet Luna's has only 60 on-ramp parking stalls that shoppers may share with building residents. (Luna's parking plan, as presented during community meetings, presumes that residents will vacate their rented stalls during business hours. There is no firm back-up plan should this plan prove inadequate.)

We appeal to you to make the best decision to ensure the success of the only full-service supermarket <u>to stand</u> <u>between food access and a food desert in South Madison</u>. This store must succeed to redress the food access inequities that plague the South Madison community. Please support Alternative 2.
