DRAFTER'S ANALYSIS: The Common Council adopted BOE Amendment 3 to the 2014 Operating Budget, which raised license fees for Public Passenger Vehicles (taxicabs) and various license fees for Secondhand Dealers. It is necessary to amend Madison General Ordinances in order to implement those budget provisions.

The Common Council of the City of Madison do hereby ordain as follows:

1. Subdivision (b) of Subsection (4) entitled "Application and Fees" of Section 9.24 entitled "Licensing of Secondhand Dealers" of the Madison General Ordinances is amended to read as follows:

- "(b) The license fees under this section are as follows:
 - The fee for a secondhand article dealer license shall be five hundred <u>fifty</u> dollars (\$500<u>550</u>) per year excepting secondhand article dealers who operate a business for buying, selling, exchanging or receiving into possession used or secondhand bicycles and used or secondhand parts of bicycles for which the license fee shall be five hundred dollars (\$500) per year.
 - 2. The fee for a pawnbroker's license is five seven thousand five hundred dollars (\$5,0007,500) per year.
 - 3. The fee for a secondhand jewelry dealer's license is two thousand dollars (\$2,000) per year.
 - 4. The license fee for a secondhand dealer mall or flea-market license shall be five hundred <u>fifty</u> dollars (\$500550) per year. A special event secondhand dealer mall or flea-market license shall be seventy-five dollars (\$75) for a period of no more than three (3) consecutive days. The license shall set forth the exact days on which such business or event may be carried on.
 - 5. The fee for a secondhand textbook dealer's license is seventy-five <u>one hundred</u> dollars (\$75.00100) per year.
 - 6. The fee for a precious metal dealer license is two thousand <u>two hundred fifty</u> dollars (\$2,0002,250) per year."

2. The Table of Subdivision (a) of Subsection (5) entitled "Licensing of Public Passenger Vehicles" of Section 11.06 entitled "Licensing and Regulating Public Passenger Vehicles, For Hire" of the Madison General Ordinances is amended to read as follows:
