MISCELLANEOUS

- License applications are still coming in. We have moved the majority of applications through workflow and to Fees Due. Our goal is to have invoices sent out to vendors that have applied by 3/1 so they have 30 days to pay before they will receive a late payment fee. Payment deadline is 4/1/20. There is a standard late payment fee of \$75 per license applied for.
- A staff team have begun to explore the potential for alternative fuel sources for Food Carts and Food Trucks. More information about this potential will be forthcoming.
- There will be construction on the sidewalks on the 100 and 200 blocks of Martin Luther King Jr. Blvd this summer. Food vendors will be relocated as needed during construction. Sidewalk café operators have been notified and will receive a construction discount for this season.
- Pre-construction meetings have been set for the planter modifications at Genna's and Boar & Barrel. Staff have worked with operators during the planning process to limit the disruption. Tipsy Cow will enter into a Maintenance Agreement with the City to allow the permanent fencing to stay after it is repaired. Tipsy Cow, Boar& Barrel, Genna's and Argus will be operating under a full sidewalk café license this season and will be subject to Sidewalk Café rules and regulations.
