The costs to fix these problems are cost prohibitive due to the very small size of the house.

Applicant's Comments: To construct 18 story mixed-use building with 291 apartments, 12,500 square feet of commercial space and parking.

Staff Findings: The preservation file for this property indicates that the vernacular brick building was constructed in 1930 as Eddie's Wonder Bar. The bar was started by Eddie Touhy with money from his brother, Roger "The Terrible" Touhy, who controlled an illegal alcohol distribution and gambling business during Prohibition, and was a leader of an Irish gang known to be a rival of Al Capone. The front and back bars were moved here from Chicago when the bar opened. In the

1930s, it was "a favorite watering hole of gangsters on their way from Chicago to the north woods." The bar and restaurant have remained in continuous operation since opening.

In 2008, the Madison Trust for Historic Preservation submitted a draft landmark nomination, but discontinued the process at the request of the property owner. The nomination made the argument that this structure was eligible to be a landmark under Criterion 1 due to its association with the Prohibition Era with this location representing the network of roadhouses constructed at the edges of cities and operated by gangsters of the era for the purpose of distribution of illegal alcohol.
