	chambers of commerce, churches, Lodges/Societies, Veteran's Organizations, and Fair
	Associations only. Being a non-profit company is not enough.

You may get an unlimited number of temporary licenses for Beer, but only two licenses for wine each twelve months.

o If your plans include using the street for your event, you will need a **Street Use Permit** and you must apply at least 60 days before your event.

At least one licensed bartender must be present.

o The fee is \$10 for beer and/or wine per event - events may have consecutive days.
