Hi folks! There needs to be a clearer method to get into the zoom to make public comments. I was on my phone on Saturday, and from the committee meeting page I was unable to figure out how to give public comment, only to get into the web version.

Anyway, here's some comments via email!

Summary:

- Need expertise in diversifying responses (transformative/restorative justice)
- Don't pause the process
- Non-combative, non-"independent": integrated into the city services, working with the community
- Need a great communicator

• Willing to fight against the "warrior police" mindset

I agree with the comment I heard that the expectations around police are shifting. Do we expect them to deal with mental health issues? Homelessness? I personally hope the city and the new chief work to find ways to create or support other groups to deal with those two types of issues in particular. For mental health and homelessness, we *should not* be sending people who are strapped with deadly weapons. The incoming police chief should hopefully be someone with expertise in diversifying responses; experience with transformative/restorative justice a definite plus. (Side note: Madison needs to put some serious thought into our homelessness issues. Policing them with force is not right. I don't have solutions, but am willing to pay more taxes if it goes to a program that actually helps instead of pointlessly policing the homeless.)

However, I strongly *disagree* with the person who said that we should "pause" the process of seeking a new police chief while our expectations settle. Any candidates entering this process are going to be VERY aware of the challenges ahead, and the shifting ground under us all. Installing someone during a period of social and other flux could actually be a *very good* thing, to break through calcified assumptions and the disease of "that's how we've always done it".

As a longtime citizen, I'm sick and tired of combative police chiefs. Mike Koval's exit interviews seemed to show he thought the police were an entity on their own. He said: "I was increasingly frustrated people aren't letting me do my thing independently." Well, guess what. The police should absolutely NOT be an independent force in the city. The new police chief should have a plan to integrate better into the city agencies. (Side note: I would also like to see more police live in the communities they serve. This goes for the leaders, too!)

In a more recent post-retirement interview, Koval said: "While literally the destruction of Madison is being witnessed, is to me, completely disappointing, and an insult to the fact that you have thoroughbreds in the Madison Police Department, literally, among the world's best in crowd management, and they are literally having their hands tied, and they're like, ponies in a little county fair walking around in circles, rather than being able to surgically and intentionally deal with disruption."

This is nonsense. First off, he can't even speak a coherent sentence, and let's just ignore the weird horse metaphor. We need a new chief who can **communicate well**. Our new police chief needs to understand that WE, THE COMMUNITY, are in control. This is not forcing them to be "ponies" in a county fair. But I'm sick and tired of police wanting to be "warriors", (or horses? what?) using force and threats (or the threat of inaction) to get more autonomy and budget headroom. Less of this mindset please.
