For the disposal of contaminated soil, Waste Management's landfill is typically half the price as Dane County's landfill. Disposal costs will continue to be bid on a project by project basis and POs will be issued for each Capitol project that requires disposal.			
COMMENTS REGARDING PURCHASES OVER \$50,000			
The City of Madison has spent \$573,375 with Waste Management since 2016. There has not been a competitive process, as City Engineering previously viewed them as a utility that manages the lower cost of two landfills available for this type of contaminated soil, and in 2019 asked Common Council for authorization to continue using them as a non-competitively selected vendor for three years via resolution #55310, passed 4/30/2019.
