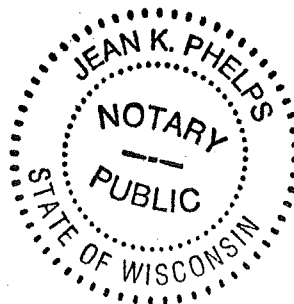

Alamir K. Morning, being first duly sworn on oath, deposes and says:

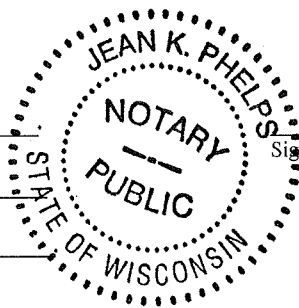
1. That the affiant owns , operates , or manages a pedal cab business in the City of Madison, doing business as Madtown Hopper LLC.
