Thank you. Your response somewhat answers my questions.

My concern is that houses on that side of the street have been tested, while not for soil contamination but for vapors, and some tested rather high for vapors.

While I understand the vapors can migrate through the soil, I don't feel it's unreasonable to assume that there might be contamination given the high vapour testing, or to have the city ask for soil testing to be done prior to a demolition and subsequent construction on a property.

My concern is with the high level of sub-slab vapour levels on the few properties tested in this side of the street (266 Waubesa) that there is soil contamination, how much so is unknown as it hasn't been tested and how much I will be exposed to during a demolition and construction process Given the widely varying levels of vapors on the 2 properties on that side of the street that were tested, there really is no way to know without testing, which is what I am asking be done prior to construction. If you could speak to the variance in levels on this block, or to offer other assurances that exposure wouldn't increase during the demolition/construction process, I would appreciate it.

Jen,

Around 10 minutes after I emailed you I received a call from Mike Schmoller from the State to clarify the answer to your question. This particular property was not tested for soil contamination and it was deemed unnecessary because other properties on this side of the street (opposite side from MKC) did not indicate that the plume had impacted this or adjacent properties. The properties on the same side of the street were the areas most impacted by this contamination.

I hope this addresses your concerns.

Based on the sampling data complied over the last several years there is no data that would suggest soil contamination from operations at MKC would impact properties on the west side of Waubesa Street. Further the vapor concentrations seen in the sub slab or indoor air at 266 Waubesa do not exceed the current guideline concentrations used by the Department. So the Department does not know of any data that would identify a risk to workers at the 256 parcel.
