The undersigned property owners do hereby protest against the rezoning of the property located at 1001 University Avenue, Madison, Wisconsin, from the R6 Zoning District to a PUD-GDP-SIP that would relocate a portion of an existing church and student center elsewhere on the same parcel and demolish the remainder to allow construction of an apartment building. The undersigned property owners represent the owners of 20% or more of the area of the land immediately adjacent extending 100 feet from the land included in the proposed zoning amendment.
