Section B-Premises

508 State St Suite B is a 4,000 sq ft commercial space on the second floor with direct access to State Street walking mall. Two exits in the rear of the unit lead to the service alleyway allowing for a second fire exit, direct delivery access to the kitchen and waste disposal. All sales and services will be conducted and consumed inside the building. There will be 4 open bay golf simulators, one private room simulator, and a full bar and dining area. The facility will have 2 bathrooms with 2 stalls each, a storage/office room and full kitchen. The interior design will utilize multiple materials creating a comfortable upscale atmosphere to accommodate UW Students, business professionals, and families.
