Fiscal Note

\$53,450 in Federal CDBG funds was approved by the Common Council for Northside neighborhood revitalization projects as part of each of the CDBG Office's 2009 and 2010 Adopted Operating Budgets, for a total of \$106,900 available for these projects.

The CDBG Office will contract directly with the Northside Planning Council for \$95,400; this Resolution transfers the remaining \$11,500 in CDBG Office funds to Metro Transit, requiring the following budget amendments.

To the CDBG Office's 2010 Operating Budget:

SC01-260000-54920 Community Agency Contracts (11,500) SC01-260000-57440 Transfer Out to Capital Projects 11,500

To Metro Transit's 2010 Capital Budget:

ET01-815010-55315 Transit Enhancements 11,500 ET01-815010-79427 Transfer In from CDBG (11,500)

No new City dollars are included in this Resolution.

Body

Background:

The CDBG Committee, in cooperation with the Planning Unit, sponsored a neighborhood planning effort in the Northport, Warner Park and Sherman neighborhoods, from which a

resident-based Steering Committee developed a neighborhood Plan which included priorities for implementation of specific objectives.

The Common Council adopted the Northport-Warner-Sherman Neighborhood Plan in November, 2009. The Steering Committee has identified two priority projects within the plan, and recommends these projects for implementation through the use of CDBG funds.

Action:

WHEREAS, the Housing and Community Development Act of 1974 permits the City of Madison to assist community agencies in the development of innovative projects which benefit low- and moderate-income people; and,

WHEREAS, \$53,450 in Federal CDBG funds was authorized in each of the City's 2009 and 2010 Adopted Operating Budgets for the implementation of eligible projects in the Northport, Warner Park and Sherman Neighborhoods, for a total of \$106,900 in available funds for these projects; and,

WHEREAS, the CDBG Committee has reviewed the specific funding recommendations from the Northport-Warner Park-Sherman Neighborhood Steering Committee and recommends their adoption in order to promote further progress with the adopted Neighborhood Plan;

NOW, THEREFORE, BE IT RESOLVED, that the Common Council approves the provision of CDBG funds for the following projects, and authorizes the Mayor and the City Clerk to enter into agreements with the appropriate agencies to implement the projects after notice to the U.S. Department of Housing and Urban Development:

- 1. Up to \$95,400 to the Northside Planning Council for the development of a kitchen incubator facility (FEED Innovations Kitchen); and
- 2. Up to \$11,500 to Metro Transit for the installation of bus shelters and benches on North Sherman Avenue; and

BE IT FINALLY RESOLVED, that the Common Council amends the CDBG Office's 2010 Operating Budget and Metro Transit's 2010 Capital Budget to authorize the transfer of funds and expenditure of the \$11,500 for the bus shelter and bench project referenced above.
