#### **Ongoing Business:**

- BRT platform construction is well underway on the Square. Surco was relocated temporarily due to the construction footprint.
- The first Dane County Farmers' Market of the season is on April 13, 2024.
- Hemp1898 requested outdoor seating for a smoking lounge. They are a retail business on State St. and are only eligible for a Merchant Vending License and outdoor seating is not an option with that license type. They did inquire about how to make changes to the Ordinance. It was recommended that they reach out to their Alder and that I would add the comment to the Staff Report.
- State St. Night Vending
  - Program materials are being created.
  - Sites have been measured and determined and the application is created and ready to accept applications.
  - Staff will be sending out an email to all licensed vendors and interested vendors.
  - Additional direct outreach will be done to the current vendors to ensure they understand the new program and how to apply.
  - Many vendors inquire about applying. Based on this I am expecting a waiting list.

## Street Vending Staff Report

### March 2024

- Outdoor Overnight Storage
  - Having to deal with other vending and not being able to store overnight due to other uses Friday – Saturday
  - Educational materials and approval process is being created and will be shared with operators.
- Carts in Parks – Staff have presented data from Carts in Parks 3.0 and are requesting to make the program permanent. Staff are requesting to focus the program on daily vending and supporting City Sponsored events such as Parks Alive, Sina Davis Movie Nights, Warner Park Rec. events, etc. Staff will continue to share list of food vendors with the community when requested. Final approval will be at the Board of Parks Commission meeting on 4/3/24.
