I remember seeing him and his crew out on weekends, working away to put in new plantings.

After several years and the construction of new bridges over the Yahara, the new pedestrian/bike path was ready for public use. And of course Ed was there for the grand ribbon-cutting ceremony. Although he eventually remarried and moved out of our neighborhood, our paths crossed again through the Madison Parks Commission. Ed and I worked together for many years on the commission's Long-range Parks Planning Committee. When you worked with Ed, there were things you could always count on: He seldom missed a meeting; he came well prepared with good tough questions; he was a thoughtful, considerate listener, especially in dealing with people he might disagree with; and he had a fine dry wit that kept meetings from ever getting too contentious.

In essence, Steady Ed was a wonderful example of a "public servant" who didn't really care about the glory or the praise. He just wanted to get good things done, for his neighborhood and for his city. Let's hope that we all carry on his strong example.
