3. Overview of Organization

Madison Parks and Capitol Off Road Pathfinders (CORP) are mutually interested in increasing recreational biking opportunities in Madison Parks. Since 2016, Cyclorcoss, as section of CORP, has been under a Fee Modification for the use of the southern area of Northeast Park (5501 Tancho Dr., previously known as the North-East Greenspace). Since the original partnership in 2016, Cyclocross has had five successful seasons from the perspective of both CORP representatives and Parks staff. In Fall 2018, Parks allowed the use of Aldo Leopold, Reindahl, Olin, Heistand, Olbrich, Garner and Marshall Parks for one day practices for Cyclocross beginners that were free and open to the public. Starting in 2019, Parks would continue to allow the use of Aldo Leopold, Reindahl, Olin, Olbrich, Orchard Ridge Valley and Marshall Parks for one day practices. The one day practice program will include both beginners and more experienced riders. There will be two track areas to accommodate both types of bikers. The program will provide the opportunity for more biking and to gauge the interest and impact of biking at these locations. The routes will be marked with flags and obstacles will be movable objects. No construction or modifications of the park is needed. Parks would like to welcome the recreational Cyclocross program again at both Northeast Park and with one day practice programs through a three (3) vear Fee Modification

4. Term of Fee Modification (May only be for a period of up to three years)

Upon signing until October 31, 2024

Northeast Park: CORP will have non-exclusive use of designated area of Northeast Park as Cyclocross course, providing a safe environment and adequate space for the public to enjoy the parks.

One-Day Practices would occur on Wednesdays from 5:30 PM to 7:00 PM. The Parks locations and dates include Aldo Leopold on 8/17, Door Creek on 8/31, Olin on 9/14, Olbrich on 9/28, Reindahl on 10/12, and Marshall 10/26.

Any other uses (ie. additional organized events or vending) are subject to standard Parks fees and permitting requirements.
