Madison Parks Behavioral Policy

Statistical Data Report December 2016



Objective

Through the process of creating a Behavioral Policy a reasonable set of standards are established outlining behaviors that do not support the intended use of park lands and a course of action to address violations. An integral piece of Madison Parks' mission is to provide safe spaces for public recreation. By creating and communicating these standards, the City of Madison expresses the collective ethic for positive land use and acceptable behavior that is fitting for the intended use of public spaces.

Background

In recent years there was a growing concern about the safety of a number of Parks and areas of Parks within the City of Madison. Parks observed positive use of a handful of parks decrease due to the presence of individuals whose behavior negatively influenced the intended use of park land for recreation.

In 2012 the Board of Parks Commissioners passed Parks Behavioral Policy to provide standard list of behaviors that did not support the positive use of park lands. This policy outlines a procedure by which individuals committing the stated behaviors would not be allowed enter parks for a period of time.
