REPORTS

Street Vending Coordinator Verbal report: This would include enforcement activity, the expansion of street food vendors to other Madison locations, participation in a long distance conference, the status quo of the online licensing system, preparations for the 2014 redesign/demolition/construction of the 700 and 800 blocks of State Street, reconsidering the space between sidewalk cafes and store fronts on State Street with reference to joint lines, new sidewalk cafes and food carts.

DISCUSSION ITEMS

- 5. Discussion Item: Request from City Parks Dept.: Establish snow day procedures, including snow day policy language in Ordinance 9.13 and/or the Mall/Concourse Regulations. The primary reasoning is to maintain a safe passage on pedestrian thoroughfares during snowy conditions. Amend Relocation of Vendors, 9.13(6)(I)(4) to add the phrase "snow removal", and add a phrase in which the Director of Planning or designee declares a street vending snow day. If a Citywide snow emergency is declared, vendors should not be open that day. On snowy days, consider having Mall/Concourse vendors arrive later and leave earlier (11:30 to 1:30 instead of 11 to 2:30). If a vendor wants to be open during or after snow falls and the Mall Crew has not had an opportunity to plow snow off their assigned site, they must not alter the location of their cart due to the presence of snow but instead must shovel the snow out of their site or otherwise choose to take the day off.
- 6. Discussion Item: Request from City Parks Dept.: Require any Sidewalk Cafe operator or Merchant Vendor to sweep the sidewalk in front of their store front if they choose to set up before 10 a.m.
- 7. Discussion Item: Consider the establishment of the Research Park Vending Area.
- 8. Discussion Item: Consider expanding City Zoning regulations to allow food carts and other street vendors to participate at festivals held on private property, such as churches, schools, and other organizations.
