I strongly oppose the plans for developing a one mile mountain bike trail in heavily used Walnut Grove Park. Although, I have to say that I strongly support having trails built in more appropriate sites. Have been an ardent mountain biker in the past and both of my children are ardent bikers at this time. Specific reasons include the following:

- A lot of effort and cost (\$75,000) for a relatively short trail. Cost comes out to approximately \$42 dollars per yard. Is this short trail less than a mile worth the risk and disruption to residents and existing utilization of this small park?
- The current path is a multi-use path currently used by dog walkers, elderly people walking (some with mobility impairments and auxiliary devices such as walking sticks), small children going to the swings and playground area, soccer players and their parents and other fans, tennis and basketball players. In short the park is used by many across the age range
- To create a mountain bike trail with challenge elements and adventure features is inconsistent with the other users. Most challenge mountain bike trails are single use and designed to be used primarily by mountain bikers.
- Have seen numerous parents teaching their children on how to ride a bike with and without training wheels on the current paved path.
- Keeping bikers off the conservancy path will be difficult. It will seem very attractive and offer it's own natural features and challenges.
- Bikers could cause distractions to players as they go by the tennis courts and also potentially disturb the numerous dogs in the dog park. The proposed trail is an accident waiting to happen with all of its liability risks.
- The path will be fairly close to the back yards of numerous residents who have enjoyed their current privacy and quiet.
- A much better alternative would be to save this current financial resource for a more extensive trail to be developed in Elver Park where the cross country trails are not much used other than in winter, offer many hills and potential features and would provide a much longer, safer and I would argue much more used mountain bike trail. Elver park is in a densely populated diverse community that would welcome such an addition to their park.

Dear Mayor Rhodes-Conway and Alders:

We support the idea of building more paths for bicycle and mountain bike riders. However, the unpaved mountain bike path proposed for Walnut Grove Park is ill advised.

Currently, Walnut Grove Park offers multiple amenities: tennis and basketball courts, children's playground, sports fields, dog park, paved walking path, and pavilion. It is used by everyone from young children to elderly and disabled adults. We have four major objections to adding an unpaved mountain bike path to this mix:

- 1. Walnut Grove is a relatively small park of just 20.25 acres. An unpaved mountain bike path would be incompatible with the topography, design, and user base of the park. Such a path would serve only a select group of biking enthusiasts, not the diverse group of current users.
- 2. Fast-moving mountain bike riders could endanger children, elderly and disabled people, dog owners, and others who use the park.
- 3. The park adjoins the Sauk Creek Greenway, which already has serious soil erosion problems. Our Tamarack Housing Association spent \$220,000 last year to create a bioswale to mitigate problems with stormwater runoff into the greenway. An unpaved mountain bike path could exacerbate such problems.
- 4. Madison has larger, more suitable parks that could more easily and safely accommodate a mountain bike path. Elver Park at 250 acres—ten times larger than Walnut Grove Park—is an obvious choice.

For all of the above reasons, we urge you to reconsider siting a mountain bike path at Walnut Grove Park.
