



# What is Redistricting



- Process of redrawing Wards and Alder Districts
- Boundaries adjusted based on population change between 2010 and 2020 Census
- Equalize population within each Alder District

Redistricting takes place at the city, county, and state level

## Census Blocks, Wards, Alder Districts



#### Census Block


- Established by the Census Bureau
- Similar to a city block
- Census data collected for each Census Block


#### Wards


- Census Blocks grouped together to form wards
- Ward population between 1,000 and 4,000

#### Alder Districts

- Wards grouped together to form ADs
- About 5 or 6 wards per AD
- Target AD population:
  - Total population / # of alder districts (20) = 13,739 (includes Town of Madison)

#### Written Criteria for Alder Districts



- 1. Have equal population.
- 2. Enhance the participation of communities of color and communities that primarily use a language other than English.
- 3. Be compact.
- 4. Be contiguous.

### Written Criteria Cont'd



5. Account for Communities of Interest.

The Wisconsin Legislative Reference Bureau (LRB) states that "[r]especting communities of interest in a redistricting plan means attempting to group like-minded or similar people so that they may elect a representative of their choice who reflects their common values in a manner relevant to legislative representation."


The Committee voted to consider the following communities of interest:

- A. Neighborhoods and neighborhood associations.
- B. Elementary school attendance areas.
- C. College students.
- D. Housing tenure/transience (owner/renter).
- E. Income distribution.

## Written Criteria Cont'd.



- The Committee is also looking at:
  - Using major roads and other physical barriers (railroads, open space areas) as alder district boundaries.
  - Ensuring various alder districts are exposed to future population growth.



# Upcoming redistricting processes, elections




- New wards/ADs take effect later this year Alders represent their current numbered district
