The City of Madison has an existing contract for Professional Services with Brown and Caldwell (B&C) to complete an engineering feasibility study on the possibility of treating Starkweather Creek storm runoff with a flocculating agent to remove Total Suspended Solids (TSS) and Total Phosphorous (TP). As part of that study, B&C is required to collect storm flow samples from Starkweather Creek and bench test the effectiveness of different flocculent agents on TSS and TP removal. The bid provided to B&C by the State Lab of Hygiene contained errors that underestimated the cost to process each sample and the B&C proposal had an error which under estimated the number of samples that needed to be tested. As a result, both the cost and the number of samples/analyses needed to complete the project exceeds the number and cost included in the project budget. This addendum will increase the project budget to fully fund the sampling and laboratory testing efforts.
