RE: Approval of a conditional use for an addition to a single-family home on lakefront property at 802 South Baldwin Street.

At its April 8, 2013 meeting, the Plan Commission found the standards met and **approved** your conditional use application for 802 South Baldwin Street, subject to the conditions below. In order to receive final approval of the conditional use, and for any necessary permits to be issued for your project, the following conditions shall be met:

1. Final plans shall be consistent with the front yard variance approved by the City of Madison Zoning Board of Appeals on February 14, 2013 for a two story addition to the non-lake side of the residence.

Please contact Janet Dailey of the City Engineering Division at 261-9688 if you have questions regarding the following eight items:

- 2. The adjacent property owners met with City Engineer and Asst. City Attorney to discuss the legal status of Morrison Court. The residents have suggested the City accept dedication of 30ft wide private Morrison Court. City Engineering has scheduled the private street to be surveyed and evaluated for potential street reconstruction following public dedication. Public dedication of this street will affect zoning set back calculations. Reference Morrison Court Engineering Project Nos. 53B0127 and 53W1622.
- 3. The applicant shall submit, prior to plan sign-off, digital PDF files to the Engineering Division (Jeff Benedict or Tim Troester). Digital copies shall be to scale, and shall have a scale bar on the plan set.

PDF submittals shall contain the following information:

- a) Building footprints.
- b) Internal walkway areas.
- c) Internal site parking areas.
- d) Lot lines and right-of-way lines.
- e) Street names.
- f) Stormwater Management Facilities.
- g) Detail drawings associated with Stormwater Management Facilities (including if applicable planting plans

Please contact Dennis Cawley of the Madison Water Utility at 261-9243 if you have any questions regarding the following two items:

4. This property is not in a wellhead protection district. All operating private wells shall be identified and permitted by the Water Utility in accordance with MGO 13.21. All unused private wells shall be abandoned in accordance with MGO 13.21.

Specific questions regarding the comments or conditions contained in this letter should be directed to the commenting agency.

<u>No</u> interior, exterior or structural demolition or wrecking activities or remodeling activities (including material reclamation activities by the applicant or a third party) shall commence nor any wrecking or building permits be issued until the applicant has met all of the conditions of approval stated in this letter.

Please now follow the procedures listed below for obtaining your conditional use permit:

- Please revise the plans per the above conditions and file seven (7) sets of complete, fully dimensioned, and to-scale plans, along with the appropriate site plan review application and fee pursuant to Section 28.206 of the Zoning Code. Also provide any other documentation requested herein with the Zoning Administrator, Room LL-100, Madison Municipal Building, 215 Martin Luther King, Jr. Boulevard.
- 2. This letter shall be signed by the applicant to acknowledge the conditions of approval and returned to the Zoning Administrator when requesting building permit approval.
- 3. No alteration of this proposal shall be permitted unless approved by the Plan Commission, provided, however, the Zoning Administrator may issue permits for minor alterations. This approval shall become null and void one year after the date of the Plan Commission unless the use is commenced, construction is under way, or a valid building permit is issued and construction commenced within six months of the issuance of said building permit. The Plan Commission shall retain jurisdiction over this matter for the purpose of resolving complaints against the approved conditional use.
