Vacation/Discontinuance of Jeffy Trail right-of-way located in part of the SE ¼ of the NE ¼ of Section 3, Township 06 North, Range 08 East, in the City of Madison, Dane County, Wisconsin. (1st AD)

WHEREAS, Jeffy Trail was dedicated to the public per Second Addition to Hawks Creek as recorded in Volume 59-033A of Plats, on pages 166-167, as Document Number 4313581, Dane County Registry; and,

WHEREAS, this portion of Jeffy Trail public right-of-way was never improved with the construction of a public street by the city of Madison; and,

WHEREAS, the city of Madison Common Council adopted Resolution 12-00875 on November 27, 2012 authorizing the execution of an Purchase and Sale Agreement between the City of Madison and the Madison Audubon Society, Inc. for the purchase of a 9.48-acre improved residential parcel located at 7960 Raymond Road to facilitate the proposed Wolfe Addition to Hawks Creek; and,

WHEREAS, the city of Madison Common Council is scheduled to approve the preliminary and final plat of Wolfe Addition to Hawks Creek per File ID No. 29417; and,

WHEREAS, the proposed Wolfe Addition to Hawks Creek changes the horizontal alignment and dedicates necessary new right-of-way for future Jeffy Trail; and,

WHEREAS, the portion of Jeffy Trail must be vacated prior to the recording of the Wolfe Addition to Hawks Creek; and,

NOW THEREFORE BE IT RESOLVED, that the City Of Madison declares that it is in the public's interest to discontinue and vacate Jeffy Trail as depicted on attached Exhibit A attached hereto and made part of this resolution; and,

BE IT FURTHER RESOLVED, following Common Council adoption, the City Clerk shall record the street vacation resolution and exhibits with the Dane County Register of Deeds; and,

BE IT FINALLY RESOLVED, upon City Clerk recording a certified copy of the final resolution with the Dane County Register of Deeds, the vacated lands shall be replatted per the approved Wolfe Addition to Hawks Creek.





Vacating a portion of the existing Jeffy Trail right-of-way located in part of the SE ¼ of the NE ¼ of Section 3, Township 06 North, Range 08 East, in the City of Madison, Dane County, Wisconsin, also being part of Second Addition to Hawks Creek as recorded in Volume 59-033A of Plats, on pages 166-167, as Document Number 4313581, Dane County Registry, being more fully described as follows:

Beginning at the southeasterly most corner of Outlot 4 of said Second Addition to Hawk's Creek, said point also lying on the northerly right-of-way line of Jeffy Trail; thence S72°39'59"E along the northerly right-of-way of said Jeffy Trail, 227.80 feet to a point of curvature; thence continuing along said northerly right-of-way line, 27.41 feet along an arc of curve to the right, through a central angle of 07°16'14", having a radius of 216.00 feet, and a chord bearing S69°01'52"E, 27.39 feet to the southerly right-of-way line of Jeffy Trail; thence N81°37'46"W, along said southerly right-of-way of Jeffy Trail, 182.06 feet to a point of non-tangential curvature; thence 187.52 feet along the arc of curve to the left, through a central angle of 18°33'22", having a radius of 579.00 feet, and a chord bearing N63°23'18"W, 186.70 feet to the northerly right-of-way of Jeffy Trail and a point on the southerly line of afore said Outlot 4; thence S72°39'59"E along said northerly right-of-way of Jeffy Trail, 108.96 feet to the point of beginning.

The bearings as referenced hereon are based upon the plat of Second Addition to Hawk's Creek, the southerly line of Outlot 4 recorded as bearing S72°39'59"E.
