RE: Approval of a minor alteration to an approved PD-SIP (Planned Development-Specific Implementation Plan) to revise the interior layout of nine residential units in a mixed-use building at 313 North Frances Street, resulting in nine bedrooms without windows.

At its July 8, 2013 meeting, the Plan Commission **approved** a minor alteration to your client's approved PD-SIP at 313 North Frances Street, subject to the conditions of approval in the January 14 approval letter and additional conditions from reviewing agencies below.

Please contact Janet Dailey, City Engineering at 261-9688 with questions about the following 3 items:

- 1. This project is currently in for site plan verification (Accela CAP ID LNDSPR-2013-00060). The Applicant shall be required to meet all conditions of the approval prior to the approval of this PD Alteration.
- 2. Storm/roof drains shall not discharge onto the sidewalk.
- 3. The applicant shall submit, prior to plan sign-off, digital PDF files to the Engineering Division (Jeff Benedict or Tim Troester). The digital copies shall be to scale, and shall have a scale bar on the plan set. PDF submittals shall contain the following information:
 - a) Building footprints
 - b) Internal walkway areas
 - c) Internal site parking areas
 - d) Lot lines and right-of-way lines
 - e) Street names
 - f) Stormwater Management Facilities
 - g) Detail drawings associated with Stormwater Mgmt Facilities (including if applicable planting plans)

Please contact Kay Rutledge, Parks Division, at 266-4714 with questions about the following 5 items:

4. Additional street trees are needed for this project. All street tree planting locations and trees species with the right of way shall be reviewed by City Forestry. Please submit a tree planting plan (in PDF format) to Dean Kahl – <u>dkahl@cityofmadison.com</u> or 266-4816. Approval and permitting of tree planting shall be obtained from the City Forester and/or the Board of Public Works prior to the approval of the site plan. Tree planting specifications can be found in section 209 of City of Madison Standard Specifications for Public Works Construction - http://www.cityofmadison.com/business/pw/documents/StdSpecs/2013/Part2.pdf.

After the plans have been changed per the above conditions, please file eleven (11) sets of the revised, complete plan set and any other documentation requested herein with the Zoning Administrator, Room LL-100, Madison Municipal Building, 215 Martin Luther King, Jr. Boulevard. The sets of final revised plans or documents will be circulated by the Zoning staff to the City department staff listed above for their signature of final approval.

Upon receipt of the aforementioned plans, documents and fees, and upon determining that they are complete, the Zoning Administrator shall record them with the Dane County Register of Deeds Office. The recorded originals will be returned to the applicant, with the recording information noted, when the Register of Deeds has completed the recording process.

If this plan is not recorded within one year of the date of approval by the Common Council, the approval shall be null and void. No demolition or construction on the property shall be permitted until the PD-GDP-SIP has been approved and recorded.

Building permits will not be issued until this process has been completed. No interior, exterior or structural demolition or wrecking activities or remodeling activities (including material reclamation activities by the applicant or a third party) shall commence nor any wrecking or building permits be issued until the applicant has met all of the conditions of approval stated in this letter.
