- Since resources for these projects are limited, a *ranking system* has been developed. If there is enough support to continue, your street will be ranked based upon the following criteria: Traffic Volume, %of Traffic Traveling 5mph over the Posted Speed Limit, Crashes, School Area, Pedestrian Area, School Walk Route, Bike Route.
- If a street does receive funding and makes it to the *project phase*, the *City will present the neighborhood with options* to install NTMP devices at locations based upon neighborhood input and engineering principles.
- A survey will be sent to a defined "survey area" based upon the affected area of the device(s) being proposed. Permanent construction of a NTMP device requires that 60% of the returned surveys support the device(s).
