These three options will not only provide these areas with 4G LTE internet speeds, but provide these services at a cost efficient price. Reliable internet is an important factor in many aspects of improvement through education and betterment. Our wireless internet speeds can provide your residents with more than 5Mbps downstream, and 1Mbps upstream.

Customer electronics requirements – WIFI based or USB accessible computers and electronic devices.

Our solution gives the property owners the ability to bulk a large amount of data, and divide it amongst all residents. 4G LTE Router

Explanation of Plans

The first option we have is to break down each unit into a cost per unit basis. This plan will require a 2 year contract per line, but prices will not change whatsoever. This gives the landlord full control over the devices and connections. This will require a one time credit evaluation for the landlord. This will be a major convenience for the landlord to be able to manage each data device on a per lease basis, meaning the tenant will not have to pass a credit evaluation, and the landlord will not have to transfer services from one person to another anytime a unit is transitioned. This price is something the landlord can work into their leases, and disable at any time. Equipment is eligible to be upgraded for promotional pricing (\$.01) every 24 months. If equipment is lost/stolen, we have used or brand new equipment available for a higher price.

The second option is a prepaid option. This would be a per tenant basis. They would start by contacting Caitlin Trowbridge or Mike LaCourse, and we would establish a prepaid account that does not require a credit check. The monthly fee is roughly same in cost comparison, but the equipment fee for the mobile hotspot is higher. This would give the landlord no liability to the account, and still provide every unit with a mobile hotspot for \$30 a month. This would need to be paid every month in order for the connection services to work. Equipment cost for the mobile hotspot will be a one time charge of \$159.99 per tenant. This can be deactivated at anytime whatsoever.
