the following conditions: Common Council renewed 06/02/2015

- 1. No liquor sales beer and wine only.
- 2. The establishment shall not sell, dispense or give away fermented malt beverages in the original container in amounts less than the amount contained in a six pack of 12 ounce bottles or cans. This is only applicable to fermente malt be verages which fall into the following categories of brands: Domestic Premium, Domestic Premium (which includes Value and Economy brands), Malt Liquor & similarly situated imported brands.
- 3. Flavored malt beverages containing up to 6% alcohol by supernay not be sold, dispensed or given away in the original container in amounts less than a four pack of 12 ounce bottles or cans. Flavored malt beverages containing over 6% alcohol by volume may not be sold, dispensed or given away in the original container in amounts pack of 12 ounce bottles or cans.
- 4. The establishment shall not sell, dispense or give away intoxicating liquor in the original container in amounts of two hundred (200) milliliters or less in volume. 'Intoxicating liquor' shall not include wine in the original container with an alcohol content of 15% or less by volume.
- 5. The establishment shall not sell, dispense or give away flavored fortified wines in the original container with an alcohol content of more than 12.5% alcohol by volume, where spirits have been added to the wine that have not been produced from the same fruit as the
