Security Plan for CuCo's Restaurant:

CuCo's Restaurant is a family Mexican restaurant. We are open for food and beverage service Sunday-Thursday from 11:00 am-9:00 pm, and Fridays and Saturdays from 11:00 am-10:00 pm. On Saturdays only, from 10:00 pm to 2:00am we have a DJ that offers Karaoke. During those hours we continue to serve a limited food menu.

Our establishment has 68 seats. We plan to employee two security personnel that are employees of CuCo's from 10:00 pm to 2:30 am on Saturdays only. These employees will have shirts that clearly are marked that they are security personnel for CuCo's Restaurant. Those employees will be tasked with monitoring the parking lot, checking photo ID's at the entrance door. They will be on duty until all patrons have left the parking lot for the evening. We will train our staff to recognize fake ID's and recognize persons who may be exhibiting signs of intoxication.

With a small crowd and two dedicated security personnel on duty, it is our intension to monitor alcohol consumption closely. Most customers will be watching the Karaoke or dancing to the music. Patrons that are under 21 are not permitted during these hours unless accompanied by a parent. In the event of a disturbance that cannot be handled through verbal interaction, the Madison City Police will be called in for assistance.
