


I, Ross A. Michaels, Wisconsin Professional Land Surveyor, do hereby certify: That in full compliance with Section 236.34 of the Wisconsin Statutes, and under the direction of William E. Keenan and Lisa A. Keenan, owners of said land, I have surveyed, divided and mapped the lands described on this certified survey map; that this map correctly represents all exterior boundaries and the subdivision of the land surveyed; and that this land is located in Government Lot 2, Section 18, Township 7 North, Range 9 East, City of Madison, Dane County, Wisconsin, containing 1.424 acres of land an is more fully described as follows:

Lot 1 and Lot 2 of Certified Survey Map Number 3199, recorded in Volume 12 of Dane County Certified Survey Maps, on pages 273 and 274 as document number 1625251, EXCEPT that portion of said Lot 1 as described in Certified Survey Map Number 11976, all more fully described as follows:



Lot 2 & Part of Lot 1, Certified Survey Map No. 3199, located in Government Lot 2, Section 18, T7N, R9E, City of Madison, Dane County, Wisconsin

- 1. No changes in drainage patterns associated with development of any or all lots within this certified survey map shall be allowed without prior approval of the City Engineer.
- Arrows indicate the direction of surface drainage swale at individual property lines. Said drainage swale shall be graded with the construction of each principal structure and maintained by the lot owner unless modified with approval of the City Engineer. Elevations given are for property corners at ground level and shall be maintained by the lot owner.
- All lots within this certified survey are subject to public easements for drainage purposes which shall be a minimum of six (6) feet in width measured from the property line to the interior of each lot except that the easements shall be twelve (12) feet in width on the perimeter of the certified survey. For purposes of two (2) or more lots combined for a single development site, or where two (2) or more lots have a shared driveway agreement, the public easement for drainage purposes shall be a minimum of six (6) feet in width and shall be measured only from the exterior property lines of the combined lots that create a single development site, or have a shared driveway agreement, except that the easement shall be twelve (12) feet in width along the perimeter of the certified survey. Easements shall not be required on property lines shared with greenways or public streets. No buildings, driveways, or retaining walls shall be placed in any easement for drainage purposes. Fences may be placed in the easement only if they do not impede the anticipated flow of water.




