Security Plan requirements - Tip Top Cabaret LLC

- 1. We will employ our own security personnel. We will have three trained security personnel who will work hand-in-hand with our Floor Manager to responsibly manage safety and capacity.
- 2. Security personnel and management will cooperatively facilitate control and clearance of parking lot to ensure quiet enjoyment of the neighborhood and to prevent any loitering.

Entrance line will be managed by door personnel with a focus on quiet enjoyment of the neighborhood. All patrons will have ID checked by door personnel upon entry.

Unruly, intoxicated, or patrons presenting false IDs will not be permitted at or around the establishment or property.

The police will be called in the event of any possible dangerous situations.

Orderly appearance will be maintained by ongoing supervision of the exterior of the property
