31-DAY UNLIMITED

My comment is that I hope you have considered that 31-day passes are likely to be used most by those who have no other option for getting to work. My coworkers with cars use 10-ride passes; they could, if necessary, commute by car or even afford a taxi on most occasions. I can't. I've been a public servant most of my life; I live in a studio apartment, have never had a car or cable TV, my cell phone bill is \$15/month or less, I eat out about once a month (usually less than \$20), I don't go to movies/plays/concerts.

I just read that the proposed fare increase for my 31-day adult pass will rise 16.4%. That seems awfully high considering the decrease in fuel costs. I recently rode buses in Albuquerque which offer 15-minute service on Sundays, \$1 cash fares, and each bus was standing-room only. Seattle seems to get longer lifespans from their buses despite the hills. I appreciate that Madison Metro needs a new garage, but a 16.4% fare increase when operating costs should be decreasing may justify bicycling and not riding the bus for most of the year; you'll probably get less income from me if the increase is enacted.

I just want to voice my opposition to the proposed increase for the 31 day pass. Why does it have to be so high with a \$7 million dollar reserve fund? I understand the need to increase the rate, but \$9.50? Milwaukee County has a more extensive system, yet that system is cheaper than ours. I strongly encourage you re-review the 31 day pass fare increase. Could you reduce the increase?

A 16% fare increase for the 31-day pass is quite high. I know it's been awhile since it was increased, but it would be helpful if it weren't so much. In my opinion, a 10% increase would be more reasonable. Thank you for your time and consideration.

I can't believe it!

Hello. I am a regular bus rider, riding several times a day, normally. I am aware of the proposed fare increases that would start in Sept. I have bought over the years many Adult 31 day passes. I couldn't believe the proposal to increase this pass from \$58 to \$67.50! That is the highest increase that I can recall. I hope to attend the hearing, if I can. I am hoping that that increase can be lowered. I hope that you do not think that ridership would remain high with such an increase. I do not have the option of other means of regular transportation, and rely on buses, but I am sure that some others will find other means of transportation, so as not be totally dependent on spending that much per month. I know that increases are needed, but by that much? Cash fares are not affected and neither are fares for UW, Madison College, Edgewood, Meriter, St. Mary's Hospitals. I think that that is not fair. I know that the cash fare increase issue caused quite a stir when increased before, but between the cash fare and the other riders at the above schools, hospitals, increases can be shared more. Please reconsider. Surely service cuts can be helped with less of an increase in the 31 day pass and other fares.

31-DAY SENIOR/DISABLED

I submit herewith public comments on the proposed 16.4% fare hike for the Senior/Disabled 31-day bus pass for which there is a public hearing on May 11, 2016 at 6:00 pm at the Monona Terrace. I find that the fare hike from the present \$29.00 to a proposed \$33.75, a 16.4 double-digit fare increase, to be highly unreasonable especially given that those of us on Social Security have been given no benefit increase whatsoever for 2016! There is no call for a double-digit hike as inflation is nowhere near that much. This is an unreasonable burden for low-income seniors and disabled folks on a FIXED income! To place a double-digit hike burden on us is outrageous! If there must be some increase, it ought to be less than double-digit! A \$2.00 or \$3.00 increase in the 31-day pass would be reasonable given the fact that Social Security beneficiaries have a zero COLA for 2016.

COMMUTE CARD

I think the proposed rate increase is too high. You should limit the rate increase to 10% or less, \$1.30 seems more reasonable. There are a lot of people that ride the bus that will have a difficult time with your proposed rate increase to \$1.40.
