DESIGN FEE PROPOSAL

PROJECT DESCRIPTION

The Project is Programming and Design of the new Metro Transit Satellite Bus Facility at Nakoosa Trail, and includes the following:

- A review and update of the space program and master site plan in the Nakoosa Trail Facility Master Plan Phase I Report: Programming and Master Planning.
- A conceptual schematic design for a new facility. The schematic design must account for the Fleet/Fire/Radio Shop Facility on the site.
- Design development, construction documents, permitting/bidding, and construction administration are not included in the scope of this project.

This Predesign and Schematic Design effort is located on Lots 2 through 6 at Nakoosa Trail and Commercial Avenue in Madison, Wisconsin.

BASIC SERVICES
