- Route 59:** Schedule shifted by 30 minutes. Service eliminated in Dunn's Marsh Neighborhood to provide direct service between the West Transfer Point and the Fitchburg Public Library and new Fitchburg Center near Research Park Dr.
- Route 72 & 73:** All trips are rescheduled to start/end on John Q Hammons Dr. at Greenway Station. Route 72 along Discovery Dr. renamed to Route 73.


ADDITIONAL CHANGES—

- Route 49:** Stops added on Fish Hatchery at Badger Rd. for transferring to/from Routes 47 & 75.
- Routes 52 & 59:** Stops added on Whitney at Odana for increased accessibility to Westgate Mall and easy transferring to/from Route 3.
- Routes 56 & 57:** Stops added on Whitney at Mineral Point for transferring to/from Route 67.






ROUTE 11




ROUTE 14




ROUTE 33







Proposed: a.m. Route




Proposed: p.m. Route




ROUTE 55




ROUTE 56


MAP CHANGE

Service eliminated in Dunn’s Marsh Neighborhood to provide direct service between the West Transfer Point and the Fitchburg Public Library and new Fitchburg Center near Research Park Dr.


Residents of Dunns Marsh Neighborhood can continue to reach Super Target and Hyvee on Fitchrona Rd. by riding Route 18 to West Transfer Point and transferring to updated Route 59. This is expected to add 15 minutes travel time from this neighborhood to this retail location.


ROUTE 72 & 73

All trips are rescheduled to start/end on John Q Hammons Dr. at Greenway Station. Route 72 along Discovery Dr. renamed to Route 73.


Schedules will be slightly adjusted, but there will be no reduction in trips.




ADDITIONAL CHANGES

Weekday To East Towne Mall




