By not giving me my full liquor license in ALRC meeting, you are not making me heart broken but instead you are making me even stronger and more encouragement to fight. All of u who sit on those chairs I know you have read a lot of books and have may be masters or bachelors degrees but dot think that the person in front of u is illiterate. What I do, I do with my heart and to the best of my knowledge. Here let me give u few proofs.




Now let's talk about Neighbors, you all have been seeing less opposition neighbors then initially when I apply, we all know that every community has some people who dose not live them self live and doesn't let others live either, dale and is wife is one of them. I can under stand if they are my customers and have interference in there way while they are coming to store or have people in my parking lot with high music and they don't feel safe to come to liquor store, the thing is that they never even been to my store, dale the neighbor was saying that I have not met security cameras requirement her some pics









I have 4 cameras to each side of building and 6 inside, cameras were in on first day of when I open store but if took me time to instal outside. I guess it's better then having no cameras then before with old owner. I have permar security system in my building, not required but for my and my employees safety, I some times have my kids with me when I am working there so I want it to be a safe place.



Now they know each and every meeting I have and they always come but for last 34 years they had no clue that they can go to meeting, the way dale represents against me seems like he's more racist then any thing else, he was saying that all I care about is making money from small airplane bottles, but when it is time to pick up garbage from frontage road they are out of town, other wise they talk about loitering and community involvement.

Last night when questions were asked to police I feel like they didn't have definite answer, no one from west police was there, a email from 1 officers to another do not tell any thing, it's been 6 months since the came and found small size bottles in my store and I don't know why is it taking time to file a case against me. 2 times police came to my store and looked at stuff no issues noted, no one mention that. One police office came and mentioned to my clerk that, "Mr Z the old owner was known to sell to minors, r u selling too" first of all, don't ask this question, find out, don't blame me for what he did.

I have been in liquor store business for 10 years, I never have conditions in my license, if conditions are placed the owner should be given time to evacuate the stuff from building or there should be a date on license until when can I remove the bottles from building, I bought almost 80,000 inventory from old owner and a store that mostly sell small bottles, so it took me time to remove them from building. I am not stupid, I know that police will come again to check but stuff that liquor companies can't take back I can't just throw in garbage or neither can I transfer to my other store, with no experience in this situation before and after finding right way to do it I removed them from store. I already have restrictions on my this liquor license, by sending those to my other liquor store, I can't afford to have restrictions on my other store license.

As per law if a license holder is in building a unlicensed person can operate register, we have back room, which of our office and most of time if I am there and 2 of us are working I do paper work in back room, we hired a person to stock shelves at that time. He was only found 2 times without any other license operator in building, not more then that, when ever under cover coop came and they seen him they just assumed that he is by himself, instead some one else was in building too, we have 2 basement and 2 back rooms.

I will keep coming for my rights, if not every month, but for sure every other month, and I will see u in common council meeting, because I am motivated to fight for my rights, dose not matter what explanation u have but I know I am right.

Looking back, loitering was the issue that caused problem and put restrictions in my license for that I am helping neighborhood the best I can, by going to meetings, donating and by picking up garbage on daily bases in my store and surrounding areas and participating in community activities (garbage pick up days) I was the only business that participated in it. There are a lot of other business in the area too but I was the only business who participated.
