I send this letter on behalf of the Schenk-Atwood-Starkweather-Yahara (SASY) Neighborhood Association in strong support of the Wil-Mar Neighborhood Association's application to the City of Madison for \$500,000 in Neighborhood & Community Development Funds to purchase the parking lot across the street from their facility at 953 Jenifer St. At our August 10<sup>th</sup> meeting, the SASY Board considered this piece as part of the larger \$1.75M renovation & improvement project that Wil-Mar is planning for the next two years. The SASY Board voted unanimously to support the project and to give voice to that support through this letter. Please accept this as an unequivocal endorsement for the investment of those funds in the project.

The Wil-Mar Neighborhood Center fills a crucial role for the surrounding near-east side neighborhood. Its diverse programming addresses base-level needs of residents, including things like childcare, a food pantry, prepared meals and health & wellness classes. Furthermore, the staff of Wil-Mar truly build community and engagement on a different level through the festivals that they organize throughout the year. This sort of grass-roots leadership and activism is what makes that neighborhood - and this city - strong.

Our endorsement of Wil-Mar's grant request recognizes another vital detail of their project; the current owners of the parking lot want to sell it, and if Wil-Mar cannot purchase it someone else will. For years Wil-Mar has been using parts of the lot for programming and storage. Much of their programming has evolved to depend on it. The SASY Board has been working closely with Wil-Mar for the past four years in the production of our own local festival, AtwoodFest. We can attest first hand to the authenticity and reliability of Wil-Mar. They do good work, and they will be reliable stewards of any funds that the City of Madison invests in them. I strongly encourage you to fully fund their request for \$500,000 to purchase the lot in question. It will truly be a worthy investment in that neighborhood and in this city.
