SUBJECT: Notice of Claim by Veridian Homes for Return of Overpayment of Park Impact Fees

Based upon the memos attached from the Parks Superintendent and the City Attorney's Office, I concur in the claim of Veridian Homes regarding overpayment of \$261,854.33 and that a refund of that amount be paid from the Citywide Parkland Fee Account. In addition, I concur in the Parks Division and City Attorney's Office analyses that \$261,029.96 was incorrectly deposited in the Citywide Parkland Fee Account and should be transferred to the Park-Infrastructure Impact Fee East District Account for park improvement projects within the Door Creek Park area.

RE: Notice of Claim by Veridian Homes for Return of Overpayment of Park Fees

On October 12, Veridian Homes filed a Notice of Claim for Return of Overpayment regarding Veridian's payment of park fees at Grandview Commons since 2002. Veridian has asserted that it has overpaid park impact fees by \$261,854.33. Attached to this memo is a copy of this notice. The Parks Division, who administers the imposition of and collection of park impact fees and fees in lieu of land dedication, has reviewed this claim and concurs with Veridian's assertion. In a memo from Parks Superintendent Eric Knepp, also attached, the Parks Division recommends that Veridian be refunded \$261,854.33 for its overpayment of park fees at Grandview Commons.

Based upon my review of the records that have been provided to me, the claim submitted by Veridian, the memo and supporting documentation prepared by the Parks Division, and my own understanding and experience in sorting through the imposition of park impact fees and fee in lieu of dedication at Grandview Commons, the City Attorney's Office concurs with the Parks Division in recommending that Veridian be refunded \$261,854.33 from the Citywide Parkland Fee Account to resolve this overpayment of park fees by Veridian at Grandview Commons.

Given the history here and the City's own accounting of what has transpired over the years, the City Attorney's Office concludes that Veridian does have a valid claim against the City for the overpayment of the park related fees as asserted in the October 12, 2017 notice. Procedurally, under Wis. Stat. Sec. 62.12(8)(a), "[a]ll claims and demands against the city shall be itemized and filed with the clerk, who shall deliver the same to the comptroller for examination. The comptroller shall within 30 days thereafter examine such claim or demand and return the same to the clerk with the comptroller's report thereon in writing, who shall place the same before the council for action at its next meeting." In addition, under MGO Sec. 2.23, "[n]o claim, demand, or suit against the City requiring payment in excess of twenty-five thousand dollars (\$25,000) shall be allowed until the same has been considered and reported upon by the City Attorney and approved by the Common Council." Of note, because Veridian is not alleging that we misused, or didn't use, the impact fees collected here or that their building permit lapsed, this is not a situation where the impact fee refund procedures of Wis. Stat. Sec. 66.0617(9) or MGO 20.11 apply. In addition, the appeal procedures available under

Sec. 20.12(1) for impact fees aren't applicable since they, again, aren't challenging the amount, collection or use of the impact fee.

It is my understanding that the Parks Division and Veridian have known of the overpayment of park fees for some time and have worked together to come up with the correct number that Veridian should request in its claim. In addition, the Parks Division and Veridian have determined that some lots within the development have outstanding or unpaid park development impact fees (now known as Parks-Infrastructure Impact Fees), and that Veridian is in agreement with using a portion of its overpayment to satisfy these amounts that are still due. Because the Door Creek Impact Fee District was already administratively closed by the City earlier this year following the enactment of the new park impact fee ordinance, these funds, determined to be \$261,029.96, can be transferred from the Citywide Parkland Fee Account into the Park-Infrastructure Impact Fee East District account. The Parks Division will need to ensure that these funds are only used for projects within the former Door Creek Impact Fee District. Once this refund is made and the administrative transfer of park fees from the land acquisition fund to the development/infrastructure fund is done, the Grandview Commons parcels set forth in Appendix A to the report from the Park Superintendent will be in full compliance with the City's park land dedication and impact fee requirements.

In light of the foregoing, and consistent with the conclusions set forth in the memo from the Parks Division, the City Attorney's Office recommends that the claim for return of overpayment be approved and that Veridian be refunded \$261,854.33 from the Citywide Parkland Fee Account. The City Attorney's Office is also in agreement that the transfer of \$261,029.96 from the Citywide Parkland Fee Account into the Park-Infrastructure Impact Fee East District account is supported and legally permissible. In effect, these fees were paid into the wrong account and should have been imposed as park-development fees rather than parkland impact fees of fee in lieu of dedication. This transfer will correct that problem.


Notice of Claim for Return of Overpayment

Veridian Homes, as the developer of Grandview Commons, has worked with the City of Madison over the past 20 years in the construction of this neighborhood that has more than 600 single family homes, 800 multi-family homes and 200 senior restricted housing units. As a part of the development, in 2002, Veridian dedicated public park space that is now North Star Park. In addition, park land dedication credits were provided for private open space and a payment in lieu of dedication payment made by Veridian in 2002. There was a remaining sq. ft. requirement to be paid as development occurred. Over the next 13 years, those payments made exceeded what was required from the plat. This is understandable given the number of phases and modifications to the plat in regard to unit counts. However, after review of all of our records, we have calculated an overpayment of park impact fees in the amount of \$261,854.33.

RE: Veridian Homes Notice of Claim for Return of Overpayment – Grandview Commons

I am writing to inform you that we have completed our review of the Grandview Commons Plat Park Impact Fees in relationship to the Notice of Claim for Return of Overpayment submitted by Veridian Homes on October 12, 2017. After a detailed review by staff, we concur that there was an overpayment of parkland impact fees, particularly fees in lieu of dedication by Veridian Homes for the Grandview Commons Plat and recommend that Veridian be refunded \$261,854.33 from the parkland acquisition fund (12405112 Parks – Citywide Parkland Fee).

The Grandview Commons Plat has a long and complex history spanning sixteen years. During that timeframe, Veridian, the Plat's primary developer, responding, in part, to changing market conditions and development trends, in particular the impact of the Great Recession and the subprime mortgage crisis on lending and housing development, has replatted and added to the original plat; the original proposed unit counts, upon which the impact fees and fees in lieu were based, have been modified; and actual development and build-out of the Plat has occurred in numerous phases spanning many years (phase 24 of the subdivision was approved in January). The final approved unit counts for the Plat, based on all approvals to date, are as follows:

**Final Approved Unit Counts for Park Impact Fees \***

Type of Unit	Units
Single-Family	613
Multi-Family	823
Elderly - Single Room Occupancy	201

\* Any unit types not requiring payment of park impact fees have been excluded from this table.

Appendix A, which is attached, lists the properties in Grandview Commons that make up this unit count and that are covered by Veridian's parkland dedications, private open space and park fee payments since 2002.<sup>1</sup>

<sup>1</sup> It is important to note that should any new units be contemplated within the Plat beyond the total unit counts approved to date, or if there is a reallocation in unit type (i.e., single family to multi-family), those changes would be subject to Parks Division staff review and potentially would incur additional Park Impact Fee charges at the current rate.

As a part of the initial plat approval process in 2002, Veridian dedicated the land that would become North Star Park. Veridian also received parkland dedication credits for private open space being created within the plat. Finally, Veridian made a payment to cover one half of the remaining parkland fee in lieu of dedication needed for the plat. Since 2002, additional parkland fee in lieu of dedication fees and parkland impact fees have been collected from Veridian for development within the Plat with the goal of covering the remaining deficiency. However, in reviewing the fees paid by Veridian over time, and comparing them to the amount of fees that should have been imposed on Veridian for this development, it is clear that, because of the manner in which Grandview Commons has been developed, even though Veridian still owes some park development (park-infrastructure) impact fees on some lots, Veridian has paid the City more park fees than were needed to address the parkland dedication requirement for the Plat. Of note, Veridian has also indicated that, in addition to the return of overpayment that it is seeking, it would like to close this Plat regarding any remaining park impact fees that may be due.

Based upon Parks Division staff's review of the impact fees collected from Veridian for the Grandview Commons Plat, and our discussions with Veridian about this matter, it is the Parks Division's conclusion that the City has received an overpayment of park land fees in lieu of dedication. By applying the average land value over the past ten years (the period of overpayment) of \$2.43/sq. ft. and using the land dedication requirements then in effect, and after adjustments are made for unpaid park development fees in the Grandview Commons Plat<sup>2</sup>, the overpayment by Veridian is confirmed at \$261,854.33.

I believe that by issuing this refund to Veridian and using a portion of the overpayment to satisfy the remaining park fees due, the Grandview Commons Plat and those parcels listed in Appendix A will be correct in their park fee payments and dedication requirements under Madison General Ordinances. It warrants noting that this type of scenario is not likely to reoccur in any other developments given current standard operating procedures to ensure a high degree of accuracy and specificity in impact fee payments going forward, and the unique nature and timing of the Plat's development. In addition, developer practices have changed since the aftermath of the Great Recession such that the prepayment of park fees on a scale similar to Grandview Commons is unlikely.

<sup>2</sup> To satisfy all remaining park development (Park-Infrastructure) fees due for the lands owned and developed by Veridian in Grandview Commons included on Appendix A, a transfer of \$261,029.96 should be made from the Citywide Parkland Fee Account into the Park-Infrastructure Impact Fee East District account. The Parks Division will ensure that these funds are only used for projects within the former Door Creek Impact Fee District, which has been administratively closed following the enactment of the updated Park Impact Fee Ordinance.
