# 4. DISCUSSION WITH CITY STAFF REGARDING THE CITY'S BOARDS, COMMISSIONS, AND COMMITTEES SYSTEM, INCLUDING DISCUSSION OF PAST EXPERIENCES AND POTENTIAL RECOMMENDATIONS FOR IMPROVEMENT.

Motion by Rothschild to suspend Robert's Rules to stand informally, second by Harrington. Motion passed on voice vote.

The Subcommittee engaged in a nearly three hour discussion with staff about issues raised in the BCC Subcommittee Report, including issues relative to lack of diversity on BCCs, varying levels of authority among BCCs, proliferation of committees, lack of training for members and chairs, rules and procedures pertaining to BCC meetings, relationship between city staff, BCC members, and alders, tendency for same people to have multiple avenues to influence the narrative on a particular issue or project, staff concerns for personal and professional safety, and the decision making process. The conversation was rich and varied. City Staff recorded the conversation and a transcript of the meeting is being transcribed. The BCC Subcommittee noted the numerous topics it wished it had more time to discuss with staff, including the possibility of an Office of Resident Engagement and Neighborhood Services (ORENS).

#### 5. FUTURE MEETINGS AND AGENDA ITEMS

The Subcommittee noted the need for additional meetings to debrief regarding what it heard today and to more fully discuss the ORENS concept.
