Public Health Madison and Dane County is running a COVID-19 mass vaccination site at the Alliant Energy Center and entered into a noncompetitive purchase of service contract for \$50,000 with Fitch-Rona Emergency Medical Services District on March 17, 2021 for ambulance services. As vaccine availability increased, eligibility criteria expanded, and FEMA and WI National Guard provided additional personnel support, we increased the number of doses we administer per hour. At the same time, the odds for an adverse effect in response to a vaccine increase and we needed more ambulance services than originally estimated.  To secure ambulance services through the end of operations at the AEC mass vaccination site on June 30, 2021, we are requesting an amendment to increase the contract by \$60,000, for a total contract of \$110,000. Fitch-Ron Emergency Medical Services District will continue to provide ambulance services, meaning at least one ambulance and EMS personnel, during the hours of operation of the mass vaccination site at the Alliant Energy Center. The urgency in needing these ambulance services, as well as the pool of EMS providers being stretched in Dane County, does not allow for a competitive process in this circumstance. |  |  |  |  |  |
