PURSUANT TO SECTION 38 OF THE MADISON GENERAL ORDINANCES AND CHAPTER 125 OF THE WISCONSIN STATE STATUTES.

Premises: 6300 sq ft main floor with central bar. Alcohol stored behind bar and in locked basement room. Kegs and canned beverages kept in walk-in cooler on main floor in kitchen.

Common Council granted 2/2/2021 with the following conditions:

- 1. Amplified sound restricted to 60 db limit at the property line
- 2. Establishment shall close by midnight Sunday through Thursday
- 3. Capacity is the lesser of 300 or as determined by Building Inspection
- 4. The sale of alcoholic beverages shall account for 75% or less of the establishment's gross receipts.
- 5. Food served until 90 minutes before closing
- 6. Promote use of outdoor designated smoking patio on side of building
