#### 2. 32522 Review Overture Contract

Discussion of Overture Center contract deliverables and potential future contract deliverables.

A motion was made by Branscombe, seconded by January, to Approve the 2023 Overture Center Annual Agreement deliverables. Commissioners reviewed and discussed deliverables and found Overture's performance satisfactory. For the 2024 performance contract the Grants Committee will meet before the 2024 performance review. Commissioners directed staff to contact the City Attorney's office and formally request segregated accounting from Overture for Overture's most recently completed fiscal year. The motion passed by voice vote/other.

#### 3. 75865 2023-2024 Annual Grants Guidelines Review

Staff presented the updated grant guidelines, application, and score form.

A motion was made by January, seconded by Luke, to Approve and Finalize the Grants Committee's proposed amendments to the 2024-25 application including edits to the language about the requirement for individual grantees to provide free public component, changing the deadline to March 1, and setting the funding floor to a minimum grants of \$1000. The motion passed by voice vote/other.

#### 4. 78236 State Street Campus Garage/Hawthorne Court Percent for Art Project

Review of SSCG project and the adhoc committee meeting duties and timelines. Mitchel Branscombe and T. L. Luke requested to be MAC's representatives to the adhoc public art committee that will guide the public art plan for that project.

#### 5. 80199 Artist At Work Grant 2024

Staff gave an overview of the 2024 artist at Work grant guidelines and application planning.

A motion was made by Branscombe, seconded by Luke, to Approve directing Artist at Work Room Tax allocation to fund 4 (four) grants of \$15,000 for creative workers whose positions will focus on attracting cultural tourism to Madison. Staff should explore the possibility of funding a City Arts intern to concentrate on developing strategies for destination marketing. This could be in partnership with the Bolz Center for Arts Administration. Staff should find out from the City Finance Director if the remaining funds can be used for things like paying for the cohort of AAW hires to attend the State Tourism Conference, hiring a speaker on the subject to present to Madison arts orgs, paying for strategically placed ads, and other expenses that would support the cultural tourism in Madison. The motion passed by voice vote/other.
