BUSINESS BY MEMBERS

5. <u>28722</u>

Consideration to allow the Secretary to administratively approve alterations to uniform sign packages for Planned Commercial Sites, Planned Unit Developments, Planned Developments and other commercial/retail/office developments.

The Secretary stated that the Commission spends a fair amount of time approving sign packages and a certain amount of that load could be eliminated with administrative approval. The Secretary cannot approve something where the ordinance indicates that it requires the body to approve it (Comprehensive Design Review, variances). Other projects that involve constant changes could be dealt with at a staff level. It was noted that if the Secretary were absent, or were to be replaced the Commission has the ability to instruct staff to bring these types back for their own consideration.
