- The new schedule was discussed, which combines the UDC process as it feeds into the Plan Commission, and also presents a uniform application for both Commissions; based on this timing sequence, a written report will be provided in a greater speed than they are provided now.

Goodhart noted that as an architect, the notion of submitting plans for an April 3rd meeting by February 20th is very difficult. Staff noted this was in response to an Economic Development Commission study and recommendations supported by an approved resolution of the Common Council that provided that changes be made to integrate these approval processes. Goodhart continued that the new process doesn't recognize that drawings could be supplemented months ahead of time prior to going to the Plan Commission based on what the UDC has approved. Wagner noted that adjustments may be beneficial.
