Ald. Rhodes-Conway believed that the Council needed to answer policy questions on committee membership (such as ideal size and possibly having flexible appointment options) before making recommendations on committee membership size.

Ald. Sue Ellingson wanted to know how difficult it was to recruit people to serve on committees. Ald. Rhodes-Conway noted that it could be difficult for some committees because they may have specific membership requirements (example: Urban Design Commission - landscape professional). She also noted that the Mayor tries to balance appointments by geography, gender, race, etc.

Ald. Bidar-Sielaff also thought the Council should look at alder representation on committees (ask the question: do some committees need three alders).

Action to be taken at the December 11, 2012 CCOC meeting.

Create a subcommittee or president's work group to review, discuss and report to CCOC on the City's committee membership:

- The housekeeping piece of committee memberships membership size of committees
- Recommend possible policy changes for example how many alders serve on a committee, specific committee member designations, flexible appointment options
