#### 2. APPROVAL OF MINUTES

#### 3. PUBLIC COMMENT - 5 minutes per speaker

Kimberley Tadder – She initiated, and supports, the request for the exemption of sugar gliders in the Madison exotic animal ordinance. She thinks sugar gliders make great pets and that they have attributes similar to dogs and cats. They have been raised in captivity in the US for over 20 years. She takes in rescues and if someone relinquishes a sugar glider to Dane County Humane Society, she is contacted and in turn contacts those in a network. These animals can no longer be imported from Australia. The only diseases she is aware of that they transmit are ones similar to those from dogs and cats.

Eric Roscoe – Registered in support of the sugar glider exemption, did not wish to speak.

5. <u>28745</u> Presentation on Healthy Dane Website - Sue Webb-Lukomski - 15 minutes

The community health assessment project is nearly ready for public launch, which will be preceded by a press event in February. This is a collaborative project between our department and community partners. A demonstration was given of the Healthy Dane website. Local indicators can be added but we are responsible for maintaining the data. The Board praised staff for bringing the project forward.

The new fiscal year resulted in a bump in our department, into an Animal Services Officer position. Interviews for the WIC Supervisor will be held next week, followed shortly thereafter by interviews for the Director of Community Health. We will also be hiring a Health Equity Coordinator to expand that team. Karri Bartlett will be moving to supervisor of community health assessment and chronic disease prevention to grow those programs. There will be a presentation on Fetal Infant Mortality Review (FIMR) in February. We received a Wisconsin partnership grant to develop a home interview process with the mothers who have lost their infant.

9. 27918 ENVIRONMENTAL HEALTH DIVISION REPORT - 5 minutes

They are involved in a project, which will be a big undertaking, for rooming house and Bed and Breakfast establishments. The county exotic animal ordinance has not moved out of committee. Madison Kipp Corporation is making corrections as part of their investigation of soil and water contamination and the data shows improvement in these areas. According to State statute, we can only license dogs and cats. There was a request from a neighborhood association to provide the number of licensed animals in that neighborhood, which was completed by Bill Buckingham, who mapped it for us.

10. <u>27916</u> OPERATIONS DIVISION REPORT- 5 minutes

Even though there were recent changes in the regulations for Badger Care Plus, in Dane County, the number of children enrolled actually increased. Dane County saw a spike in population as well as increased numbers of ethnic groups, the largest increase was seen in Chinese speakers. This will mean translating our documents into Chinese, which we hope to do by year end. Media activity has been big this year already, in part due to increased flu activity. The activity on our website grows each year, and that is in part to the great job of the department website team.

Joe Grande from Water Utility provided an overview and history of the service connection requirement. After encountering some difficulties with the requirement and meeting with well owners, Alders Weier, Cnare and Clear made modifications to the ordinance. As part of the permit process, there is a requirement for nitrate and bacterial testing as a condition of issuance or renewal. Public Health will work with Water Utility to do initial inspections to meet state code and assure safe water.
