#### **PUBLIC HEARING ITEMS**

 1. 17567 5802 Odana Road - Comprehensive Design Review in UDD No. 3/Street Graphics Exception for an Additional Ground Sign for "Don Miller Mazda." 19th Ald. Dist.

The motion noted that the application did not meet the standards for Comprehensive Design Review which was at issue with the previous approval.

A motion was made by Cnare, seconded by Harrington, to Place On File Without Prejudice. The motion passed by voice vote/other.

2. 13091 3019 East Washington Avenue - Exterior Remodeling and Site Upgrade in UDD No. 5. 6th Ald. Dist.

This item was approved as a consent item.

The motion required address of landscape comments from Commissioner Slayton as noted:

Replace the Crab tree with major deciduous tree (Autumn Spire Maple).

- Replace Ribes with native deciduous shrubs (Compact Viburnum or similar).
- Replace stone and shredded hardwood bark mulch.
- Provide low Evergreen shrubs or perennial/ornamental grasses around the signage.
- Heuchera will not thrive in this setting. Consider substituting with Dwarf Fountain grass.
- Provide 4-6' height shrub plantings around the dumpster. Evergreen and/or deciduous massing.
- Add Evergreen trees or native Understory tree grouping in area of removed trees.

A motion was made by Cnare, seconded by DeChant, to Grant Final Approval. The motion passed by voice vote/other.

 29803 4323 East Towne Boulevard - Planned Commercial Site, "Doolittles Woodfire Grill." 17th Ald. Dist.

The motion provided for the following:

- The applicant shall coordinate work with the mall operator and Traffic Engineering to figure out
  how to provide pedestrian access across the site, and resolve safety and pedestrian crossing
  issues with the ring road, including a tighter forming radius.
- · Submit a lighting plan to staff.
- Break up the long expanse of parking by providing an additional tree island that may act to
  extend the garden into that space.
- The shutter infill is not to be spandrel but comply with ordinance.
- The canvas awning shall match in color as shown on the drawings.
