1. <u>16466</u> Introduce New Madison Arts Commission Member

Members introduced themselves to Sheri Carter, the new Council representative on MAC.

2. <u>35889</u> Public Art Subcommittee Report

Yvette Pino, Public Art Committee Chair reported: The Public Art Committee met last night. We discussed our working draft of the deaccession policy. We need to further refine that document in the coming weeks and anticipate bringing you a draft policy for your review and approval in July.

We reviewed and discussed the remaining public art budget for this year and propose the funding be spent as follows: There is \$80,000 in our 2015 budget. That budget includes previously approved Art in Public Places funding of \$6,329 for a gateway type piece in Brittingham Park near the Community Garden and \$10,000 for underpass arton Old University Ave. We recommend staff open a call for proposals for Art in Public Places as soon as possible and that up to two site-specific 3D sculptural projects are funded with up to \$10,000 matches (not to exceed \$10,000), we also recommend that \$20,000 be spent on maintenance and conservation efforts particularly on the Sid Boyum sculptures on the near east side and the Capitol Square Fountains. Finally, we recommend that the remaining funding be reserved to explore the possibility of partnering with the UW Madison Arts Institute to commission a work of public art beneath the Monona Terrace on John Nolan Drive that accentuates the Haas Mural as a cultural relic and enlivens the underpass as a gateway to Madison.

We also discussed the percent for art policy. The committee recommends that MAC direct City staff to present a draft policy that establishes 1% as the percentage (we considered a range of .25% to 2.5% and decided that 1%,, being the most common percentage, would be a fair starting point for discussion), we also recommend that the maintenance be the responsibility of the agency that is otherwise responsible for the land and facilities upon which the artwork is located and that ongoing maintenance be paid for from that agencies budget, finally, we recommend that if the City requires artists to waive their VARA rights, that they reassign copyright to the artist in the contractual agreement, but that the contract also gives the City the right to use images of the artwork for purposes other than profit.

A motion was made by Pino, seconded by Contreras, that MAC formally Approve the recommendations of the Public Art Committee. The motion passed by voice vote/other.

3. <u>21297</u> BLINK Proposal Review

This spends \$4500 of our Blink funding. We spent \$1500 in our last round. We will have \$4000 left in our Fall grant round.

A motion was made by Pino, seconded by Karlen, to Approve Willy St. HOPE Photo project at \$1500, Wyatt Agard sound and light at Tenney Ped Bridge \$1500, Bulbous Buffont dance performances at bus stops \$1500. The motion passed by voice vote/other.
