PUBLIC HEARING - REQUEST FOR ISSUANCE OF CERTIFICATE OF APPROPRIATENESS

1. <u>41735</u>

306 Lathrop Street - University Heights Historic District - Construct a new garage building, proposed plans have been altered from previous approval. 5th Ald. Dist.

A motion was made by Rummel, seconded by Andrzejewski, to Approve the Certificate of Appropriateness for the garage design as proposed with the recommendation that the applicant receive Zoning review and approval of the height of the garage building and work with Landmarks Commission staff if any modifications to the height are required. 2. 41943 1108 Jenifer Street - Third Lake Ridge Historic District - Replace 10 windows.

A motion was made by Slattery, seconded by Andrzejewski, to Approve the Certificate of Appropriateness for the window replacement on the sides and rear with the condition of approval that the existing wood windows on the front façade be repaired and that the Applicant shall work with staff on any outstanding issues. ADVISORY RECOMMENDATION

40361 1801 East Washington Avenue - Development of property adjacent to a
Designated Madison Landmark - the Yahara River Parkway. 6th Ald. Dist.

A motion was made by Rummel, seconded by Andrzejewski, to advise the Urban Design Commission and Plan Commission that the proposed development is not so large or visually intrusive as to adversely affect the historic character and integrity of the adjacent landmark site. The motion also included a recommendation that the Urban Design Commission take a close look at the stair tower lights, the signage areas, and the landscape treatment on the parkway portion near East Main Street. NEW BUSINESS

4. 41826 Review of Landmarks Commission Nomination Forms as required by Ordinance

Staff described the proposed Historic Resource nomination form and that it will be offered on the city website in multiple formats. There was general discussion about the form including the ability for the preparer to use a map with the boundary indicated in lieu of using a legal description and reworking the sentence structure in the instructions. Staff will make revisions and provide the form for Commission review at a future meeting.

6. <u>41270</u> Buildings Proposed for Demolition - 2016

A motion was made by Slattery, seconded by Andrzejewski, to report to the Plan Commission that the Landmarks Commission finds that the building located at 4602 Cottage Grove Road has no known historic value and that the six buildings on West Washington and North Broom collectively have historic value that contribute to the larger vernacular context of Madison's built environment, but the buildings themselves are not known to have historic, architectural or cultural significance, and that a separate report will be submitted. The motion passed by a voice vote.
