D.1. 45741 Madison Police Department Traffic Reports, Third Quarter 2016 - PBMVC 01/24/2017 Presented by Lieutenant Trevor Knight

Determining a Public Purpose and Necessity and adopting a Relocation Order for the acquisition of land interests required for the construction and maintenance of a portion of the Demetral Park Path, a new shared-use (bicycle and pedestrian) path from E. Johnson Street at Pennsylvania Avenue to connect to the existing path in Demetral Park. Located in part of the NE ¼ of the SW ¼ of Section 6, T7N, R10E. (12th AD)

City Engineer, Chris Petykowski, gave a staff presentation on the relocation order for the Demetral Path.

A motion was made by Zellers, seconded by Kemble, to Recommend returning to lead with following recommendation of amending the verbiage of the resolution to say: "NOW, THEREFORE BE IT RESOLVED, that the City of Madison requests that the DOT study converting Stoughton Road (Highway 51) to an urban boulevard with the Madison city limits;" The motion passed by voice vote/other.
