Ald. Marsha Rummel shared her thoughts on having committee reports at the CCEC meeting that would provide information and updates on policy initiatives and issues. CCEC members agreed with the concept. There was discussion on how that would be accomplished.

Ald. Shiva Bidar-Sielaff recommended that the first report be focused on:

- 1. Violence Prevention Efforts
- 2. Transportation
- 3. Development

Ald. Rebecca Kemble requested that development be replaced with affordable housing.

It was also recommended that reports be approximately 15 minutes in length. First report tentatively scheduled for August 1, 2017 CCEC meeting.

Update on Chief of Staff Hiring Process (7/11/17) - Council President Marsha Rummel

Ald. Marsha Rummel provided an update on the Chief of Staff hiring process. Noted that they are assembling participants for the resume screen process and the first interview panel. It was suggested by CCEC members that department heads also be considered as participants.

A motion was made by Ald. Shiva Bidar-Sielaff, seconded by Ald. Matt Phair, to approve.

Registration: Carl Landsness registered to speak. Noted that communication was critical in the process and would like to see the legislative and executive branches working together on this initiative.

Ald. Sara Eskrich spoke to her resolution and highlighted points from her memo (attached to file):

- 1. Structure smaller task force, practical and meaningful propose (avoid quorum issues and alders are already elected by residents)
- 2. Public Engagement Process this task force charged with developing and implementing an engagement process (vs. relying solely on a committee as

the engagement tool)

There was discussion on the differences between the Mayor's resolution and Ald. Eskrich's resolution. One of the main differences was the size of their committees. Ald. Eskrich's resolution: 7 members consisting of four alders, three citizens and the Mayor's resolution: 17 members consisting of two alders, 15 citizens.

Ald. Denise DeMarb noted any changes that would result from the review process would take effect after the 2020 census and would not immediately benefit the current Common Council.

A motion was made by Ald. Rebecca Kemble, seconded by Ald. Samba Baldeh, to re-refer to the COMMON COUNCIL EXECUTIVE COMMITTEE and should be returned by 7/18/2017. The motion passed by voice vote/other.

Ald. Denise DeMarb moved to approve for discussion purposes, seconded by Ald. Sheri Carter. The motion passed by voice vote/other.

Mayor Soglin was present to discuss his resolution. He noted that a review of the city's governance structure should be dominated by residents of the City of Madison vs. elected officials from the legislative and executive branches. There was a role for experts as a resource, not as decision-makers on a committee.

Ald. Kemble asked if he would be amendable to including a study of the Mayor's office in Ald. Eskrich's resolution (was not included in her resolution). The Mayor said that it would be appropriate due to the points of authority in appointing authority, the Mayor as a member of the Common Council (chair, voting in case of tie). The Mayor also recommended that the CCEC consider Prof. Arlen Christensen (Professor of Law Emeritus) as a resource due to his experience and knowledge of municipal law.

A motion was made by Ald. Rebecca Kemble, seconded by Ald. Denise DeMarb, to re-refer to the COMMON COUNCIL EXECUTIVE COMMITTEE and should be returned by 7/18/2017. The motion passed by voice vote/other.
