Heather Allen, Council Legislative Analyst, presented information on research she conducted for Ald. Sheri Carter on Civilian Oversight of Police.

In addition to Ms. Allen's PowerPoint presentation she distributed a memo from City Attorney May to the Mayor entitled, "Legal Considerations Regarding Independent Investigation of Police Officer Involved Shooting Incident" dated January 14, 2013 (attached PDF).

CCEC members requested the City Attorney to review and provide analysis on the three (3) options listed in his memo for further discussion by the committee:

(a) establishing some sort of body or person to conduct an independent investigation or review of this specific incident;

(b) establishing such a body on a permanent basis, looking at the range of options used in other cities; or

(c) asking the Police Chief to institute a policy listing the circumstances under which the Police Chief is instructed to use an outside investigator or review.

Ald. Shiva Bidar-Sielaff requested that Ms. Allen contact the co-chairs of the MPD Policy & Procedure Review Ad Hoc Committee and request time to present this information to that committee.

Ald. Rebecca Kemble moved to add "and confirmed by the Common Council" after "...to include 2 Council members", seconded by Ald. Bidar-Sielaff. Motion passed.

Ald. Rebecca Kemble moved to amend the resolution with redlined/strikeout amendments (distributed to committee), seconded by Ald. Mike Verveer. Ald. Bidar-Sielaff requested that the following Whereas clause be deleted, "Whereas, the City of Madison elected officials and senior staff identified six value-based outcomes to prioritize in future budgets and critical decision-making" and the following be re-worded; "Effects of governance models on efforts to increase social equity" to "Effects of governance models on efforts to increase racial equity and social justice". Motion was considered friendly.
